Data protection overview

General

In this overview you can read what happens to your personal information when you visit our website. Personal information is any data with which you could be personally identified. Detailed information on the subject of data protection can be found in our privacy policy found below.

Data collection on our website

Who is responsible for the data collection on this website?

The data collected on our website are processed by the website operator. The operator's contact details can be found in the last section of this document.

How do we collect your data?

Most data collected on our website is data that the visitor provides to the operator via forms. Other data is automatically collected by our IT systems when you visit the website. This data is primarily technical data such as the browser and operating system you are using or when you accessed the page. This data is being collected automatically as soon as you enter our website.

What do we use your data for?

Part of the data is collected to ensure the proper functioning of the website. Other data can be used to analyze how visitors use the site and in order to provide them of the necessary information when given legal consent.

What rights do you have regarding your data?

You always have the right to request information about your stored data, its origin, its recipients, and the purpose of its collection at no charge. You also have the right to request that it be corrected, blocked, or deleted. You may also, of course, file a complaint with the competent regulatory authorities.

Analytics and third-party tools

The website operator may create statistical analyses of general and specific surfing behavior by collecting cookies and measuring user behavior with google analytics and other tools. How do we collect your data?

You directly provide Accelleran with most of the data we collect. We collect data and process data when you:

- Leave a message on the contact page.

- Use or view our website via your browser's cookies.

What are your data protection rights?

Accelleran would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request Accelleran for copies of your personal data. We may charge you a small fee for this service.

The right to erasure - You have the right to request that Accelleran erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Accelleran restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Accelleran's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Accelleran transfer the data that we have collected to another organization, or directly to you, under certain conditions. Data collection on our website

Cookies

Some of our web pages use cookies. Cookies do not harm your computer and do not contain any viruses. Cookies help make our website more user-friendly, efficient, and secure. Cookies are small text files that are stored on your computer and saved by your browser.

What types of cookies do we use?

Analytics and advertising

Google Analytics

This website uses Google Analytics, a web analytics service. It is operated by Google Inc., 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA. Google Analytics uses so-called "cookies". These are text files that are stored on your computer and that allow an analysis of the use of the website by you.
